# Minutes of Board of Directors Meeting October 16, 2023

The Board of Directors of the Chautauqua, Cattaraugus, Allegany and Steuben Southern Tier Extension Railroad Authority held a meeting at 9:30 AM on Monday, October 16 in the Conference Room in the office of the Southern Tier West Regional Planning and Development Board, 4039 Route 219, Suite 200, Salamanca, New York. #### 1. Call to Order and Introduction of Those Present

Recognizing a quorum, Chairman Jay Gould called the meeting to order at 9:30 a.m. Introductions were made of those present.

#### 2. Reading and Approval of the Minutes of the March 20, 2023 Meeting

The Board adopted a resolution approving the minutes of the March 20, 2023 Board Meeting (Dixon, Scott, passing unanimously).

#### 3. Officers

The Board approved officer positions of Jay Gould, Chairman and Steve Havey, Vice Chairman (Malter, Prete, passing unanimously) and the appointment of John Malter to second Vice Chairman (Prete, Scott, passing unanimously).

#### 4. Communications

Mr. Zink updated the Board on communications from Allegany County nominating Steven Havey and Gary Barnes to the STERA board.

#### 5. Treasurer's Report

Mr. Zink presented the Treasurer's Report for September 30, 2023. Mr. Zink noted that the Audit Committee had met to review and approve the financial statements.

For the year to date ending September 2023, the treasurer reported the following:

- Net income of \$15,750.08 on revenues of \$920,922.99
- Net assets of \$3,833,948.22 on assets of \$3,838,948.22
- Cash balance of \$91,752.22
- Accounts payable \$5,000.00
- Accounts receivable and grants receivable \$0.00

The following treasury resolutions were adopted:

- Approval of the Treasurer's Report for September 30, 2023 (Havey, Dixon, passing unanimously)
- Approval of four checks:
  - o Admin payment to Southern Tier West RP&DB in the amount of \$5000
  - 2% grant admin payment to Southern Tier West RP&DB in the amount of \$17,618.46
  - o Payment to WNYPRR in the amount of \$47,520.84
  - Future check to be written for D&O insurance; Mr. Zink will notify board of amount in advance (Keis, Malter, passing unanimously)

## 6. Reports of Committees

#### A. Audit Committee

The Audit Committee met earlier that day, reviewed and approved the financial statements, and recommended that the Board approve the statements (Kerper, Scott, passing unanimously).

The Board also approved the 2024 Budget and the Four-Year Financial Plan 2024-2027 (Dixon, Benson, passing unanimously).

#### **B.** Governance Committee

The Governance Committee met and reviewed the financial disclosure and ethics report, and recommended that the Board approve it. The Board approved the report (Malter, Kerper, passing unanimously).

#### 7. Old or Unfinished Business

#### A. WNYP RR Operating Status Report

Vice president for sales and marketing Jeff Bauman provided a report to the Board. Mr. Bauman said that there continues to be increased interest in rail. One hundred cars have been brought to Cuba for storage. The tracks from Olean to Hornell have been repaired using sonar testing. Cimolai's new plant in Olean is ready to begin using rail service.

# B. Status Reports on Current and Proposed Rehabilitation Projects

Mr. Bauman updated the board on the following projects and explained that the Front Street PFRAP bridge repair is held up at the state level due to MWBE requirements.

#### 1) Active Projects:

- NYSDOT PFRAP Bridge Repair and Tie Installation Project (Southern Tier Extension Line and Buffalo Line)
- NYS DOT PFRAP Olean Enginehouse and Yard Improvement Project
- STERA Tie and Rail Replacement PFRAP Project (Southern Tier Extension Line)

# 2) Proposed Projects:

 Proposed Bridge NY Project (Salamanca Main Street Bridge Replacement and Track Realignment, Southern Tier Extension Line)

# C. Seneca Nation Representation on STERA Board

It was agreed that STERA will write a letter to the Seneca Nation council inviting representation on the STERA board.
